Procedures for Opening/Closing the Center for Nonmember Rentals Usage. We have several rentals coming up. Volunteers are needed for each month to provide access to the SSC building for nonmembers. Key card access to the building is limited to staff, members and directors of the SSC. Many of our members will not drive during the hours of darkness. This has produced a conundrum for the use and access to the building for nonmembers and rental usage.
